Office of Research and Sponsored Programs (ORSP)

The Collaborative Institutional Training Initiative (CITI Program) is recognized by the University of Houston – Downtown in serving some of our research compliance training needs. There are many courses available free of charge to UHD employees including:

- Human Subjects Research (HSR) required for all faculty, staff and students planning to work on human subjects protocols, required as part of new protocol application process valid for 3 years, with the following versions:
 - SBR Investigators direct contact with human subjects
 - Life/Physical Science faculty or students no direct contact with human subjects
 - IRB Committee for CPHS committee members
- **Responsible Conduct of Research (RCR)** required for all faculty, staff and students working on external research funding no expiry date
- **Conflicts of Interest (COI)** required for all faculty, staff and students working on external research and scholarship funding, DBA/CBA and other research support staff valid for 4 years
- **Biosafety/Biosecurity** required for all Biosafety Level 2 laboratory based faculty, staff and students valid for 1 year

- Go to 'Register' top right of screen
- Screen 1: 'Select your Organization Affiliation' <u>– type in 'Houston' or 'Downtown'</u> and select 'University of Houston-Downtown' from the dropdown, agree to statements
- Screen 2: Fill in personal information: names, UHD e-mail address, secondary e-mail address
- Screen 3: Create username, password and security question
- Screen 4: Answer questions and make applicable selections
- Screen 5: Answer if you want to collect CME
- Screen 6: select language as English, fill in required info select role as either 'Principal Investigator' for faculty or 'research administrator' for staff
- Screen 7: select courses that apply, leave others as 'not at this time'
- Complete and Finalize Registration
- Go to 'my courses', UHD 'view courses'
- Required courses should now have been added to your 'My Courses' list for you to complete

EXISTING USERS:

- 1. Log in with username and password
- 2. Check that University of Houston Downtown is already your selected affiliate institution
- 3. Go to 'my courses', UHD 'view courses', 'add a course' at the bottom of the page

- 4. Answer the questions for the course areas you wish to take now e.g. Q1: Human Subjects Research, Q2: Responsible Conduct of Research, Q5: Biosafety/Biosecurity, and Q7: Conflicts of Interest. Mark other questions as 'not at this time' or leave blank.
- 5. Courses should now have been added to your 'My Courses' list for you to complete
