## **Institutional Obligations:**

- 1- SACSCOC member institutions are required to notify the Commission of changes in accordance with the substantive change policy and, when required, seek approval prior to the initiation of changes prior to implementation (http://www.sacscoc.org/pdf/081705/SubstantiveChange.pdf)
- 2- Member institutions are required to have a policy and procedure to ensure that all substantive changes are reported to the Commission in a timely fashion.
- 3- Proposals and notifications to the Texas Higher Education Coordinating Board (THECB) are more expansive and also need to be sent in a timely manner.

**Definition:** Substantive change is a significant modification or expansion of the nature and scope of an accredited institution. Under federal regulations, substantive change includes the following types of changes (circle yes or no):
